A NEW APPROACH TO THE ORGANIZATION OF THE COSMOS

A GRAPHICAL COSMOLOGY

The Cosmogony is being evolved to show the relationship of the material cosmos to the "Spiritual Creator" based on the latest optical and radio astronomy data. Astronomers, astrophysists, cosmologists and theologians are already contributing their services.

In order to present the Cosmology with as much clarity as possible, it is being developed on a graphical basis, starting with a Cosmography of our Milky Way Calaxy, and then expanding it to the whole cosmos. Basic astrophysical research already started indicates that our Milky Way Galaxy is ellipsoidal, with dimensions of approximately 184,000 light years in length, by 62,000 light years in width and thickness. These dimensions result from radio astronomy data and are now being compared with optical data. Our galaxy is apparently only one of an estimated 10 of similar size, so arranged around a projected "dark island" center that the region of space involved would be approximately 500,000 light years diametrically. This region of space will be called a "Superuniverse" and there is radio evidence that there are more "Superuniverse"regions. There is sufficient optical evidence to show there are up to 7 "Superuniverses" which apparently orbit around a most unique as well as the only fixed position in space. This central region, involving the 7 "Superuniverses" or 70 galaxies similar to our own Milky Way Galaxy, is almost completely formed and stabilized. Dimensionally this central region is approximately 3,000,000 light years diametrically. It is surrounded by a minimum of four immense outer space levels which logarithmically double in size for each level. Each space region rotates around the fixed center in opposite directions, to provide cosmos stability. These outer space regions are all in the process of development and house the nebula and galaxies that provide the "red shift data" which presently leads astronomers to the expanding universe concept. This alternate rotating space level approach provides a much clearer understanding of actual nebula behavior. The estimated 1,000,000,000 diametrical light year "Grand Cosmos", thus takes on a new shape, visualized as an immense, "Cosmos Wheel", with the fixed center as the hub around which gigantic concentric regions of space move in reverse directions. This concept gives dimensions to present creation but simultaneously states it is infinite and ever expanding.

For our Milky Way Galaxy radio astronomy data has positioned a minimum of 10 "high intensity energy emitting sources" all specially grouped and lying on what is called the galactic equator. In order to be detected by radio telescopes, the measured energy must come from mass of electronic origin. The radio astronomer has thus positioned material

spheres hitherto unseen by an optical telescope. The huge sphere believed to be positioned at the center of our galaxy is estimated by radio data to be one light year in diameter (5,800,000,000 miles of mass of the same density as a planet). This sphere is believed to have a cool surface temperature and be a non-thermal emitter (i.e.not a sun). So far however, the unique "Architectural Spheres" on the galactic plane have been restricted to a 75° sector, indicating that they may be at center of gravity (C.G.) locations for only parts of the galaxy, or certain "Star Cloud" groups. Optical data also shows that there are many pecular proper motions to groups of stars, both next to and at a distance from our solar system. variation in motions may now take on a new meaning when it is visualized, that there are several more subsystems in each of these larger "Star Cloud" groups. Hence, each subsystem has a dimensionally smaller "Architectural Sphere" at its C.G., which controls the dynamical motions of the suns in that region of space. By the existence of the "Architectural Spheres" it is possible to develop magneto-hydrodynamical equations involving the effect of gravity. which permit the dynamic stability of regions of suns moving next to each other but in opposite directions.

The existence of these "Spheres" also permits the development of a galactic force law that is not a true inverse square relationship but which meets the data of "Statistical Astronomy". It now appears possible to establish for all pervading space a universally stabilizing "Linear-Gravity" relationship - the basic force-field of all the cosmos.

The locating of the "Architectural Spheres" by radio astronomy which apparently do not emit or reflect in the "Visible Light Spectrum" (i.e. can not be seen by the human eye), immediately established for mortal man the location of "the many mansions of the father" in heaven. Philosophically one can now escape the mundane plane and begin to understand the puissant energy systems of a mindal and spiritual realm. A new understanding of "Overcontrol" of all physical matter by a "Universal God" aided by his many echelon of "Celestial Hosts" can now be woven into our known material realm. There can now be developed a vastly expanded theology which is not only capable of verifying all present ecclesiastical concepts but clarifies many dogmas of "Earthbound" theologies.
