Proposed letter to Clyde Bedell about aBC distributing ancoder to Bastones (DRAFT) Since there is agreement that the Concordex of The URANTIA Book, being like an index, can be a useful study aid for students of The URANTIA Book, we wish to outline in this letter an agreement between URANTIA Brotherhood Corporation and yourself, author and publisher of the Concordex, wherein the Corporation will act as distributor of the Concordex to bookstores with which the Corporation does business in the sale of The URANTIA Book. To date the Corporation has filled orders for the Concordex from individuals. Our agreement will expand this to include retail bookstores. It is further understood that you will sell the Concordex to the Corporation at a 50% discount of the recommended retail price. The Corporation will sell the Concordex to any licensed bookstore, offering the same discount rates that apply to the sale of The URANTIA Book. It is also agreed that the Corporation will notify by letter all bookstores with whom it does business that it has become the distributor of the Concordex. This letter will in good faith present the Concordex as a useful study aid for students of The URANTIA Book. From time to time, based on the decision made by the fourteen member Board of Directors of the Corporation, additional letters may be sent to bookstores reminding them of the availability of the Concordex through the Corporation. There will be no other promotion of the Concordex by the Corporation. It is understood that you will not engage in any advertising or mass media promotion without the prior written approval of URANTIA Brotherhood Corporation. This agreement can be cancelled upon sixty (60) days prior written notice by a majority vote of the fourteen member Board of Directors of URANTIA Brotherhood Corporation or by you when either party determines this agreement is no longer suitable. Cancellation may be based in part on, but not limited to, actions of either of the two parties involved that violate the spirit of this agreement. If these arrangements are satisfactory to you, please sign and return the enclosed copy of this letter. JH/jh 10/5/78

Martin and Clyde Ways to modify Agreement suitable to hdqtrs and Clyde for Brotherhood to sell Cncrdxs to bookstores

- Letter of Agreement should state that the Concordex is a valuable tool for readers and the movement, and the Brotherhood wishes to distribute it to bookstores.
- 2. The Brotherhood will inform bookstores selling 80% or more of URANTIA Books that an INDEX, the Concordex, is available from the Brotherhood. This letter will in good faith creditably present the Concordex with a view to getting it carried by stores selling the URANTIA Book. Additional letters may on occasion be sent until the fact registers with bookstores, if first approved by Brotherhood and an agreeable sharing of expense can be arrived it.
- 3. 2. The Agreement may be cancelled by either party for cause. If Clyde violates the spirit of the Agreement, or does something definitively harmful to the movement, Agreement may be cancelled by majority vote of Corporation. If hdqtrs does anything hurtful to Concrds's purposes, sale, or use, or is suppressive of Cncrdx, Clyde can cancel.
