He came to Culver as pastor of Grace Church in June, 1950, from Elmhurst College where he had served as chairman of the Department of Psychology, Earlier he served as pastor of Trinity Church in Mulberry, Ind., for eight years.

As a forceful and eloquent speaker he has appeared before many church and civic conferences throughout Northern Indiana. He is past vice-president of the Indiana-Michigan Synod of the United Church of Christ.
