ASSIGNMENT and QUITCLAIM

WHEREAS URANTIA Brotherhood Corporation, a corporation organized and existing under the laws of the State of Illinois, one of the United States of America, located and having its principal office at 533 Diversey Parkway, Chicago, Illinois 60614, United States of America (hereinafter referred to as "Brotherhood Corporation"), has heretofore - commencing on or about September 29, 1969 - made certain uses in Australia of two trademarks - namely, the word "URANTIA", and a symbol composed of three concentric circles (hereinafter referred to as "the Marks") - on and in connection with printed publications, particularly books; and

WHEREAS Brotherhood Corporation has made the aforesaid uses of the Marks in connection with the packaging and shipping of printed works published by URANTIA Foundation - a religious educational foundation created by Declaration of Trust, having its principal office at 533 Diversey Parkway, Chicago, Illinois 60614, United States of America (hereinafter referred to as "the Foundation") - which printed works have been shipped by Brotherhood Corporation to various addressees in Australia; and

WHEREAS all the foregoing shipments were and have been

and request of, and its capacity as agent for, the Foundation, and Brotherhood Corporation has at all times recognized the Foundation as the proprietor of the Marks for use in connection with printed publications, particularly books, and Brotherhood Corporation had no intention of seeking or of acquiring separate or independent rights in and to the Marks by virtue of its aforesaid uses of the Marks in Australia ; and

WHEREAS Brotherhood Corporation is informed that
it is possible that its display of the Marks, on and in
connection with the packaging and/or shipping of printed works
as aforesaid to Australia (prior to any use of the
Marks in connection with such ware by the Foundation in
Australia) may have created separate and independent
rights in and to the Marks in Australia in Brotherhood Corporation; and

WHEREAS it is the desire of the parties that the Foundation be recognized as the sole owner and proprietor of the Marks throughout the world;

NOW, THEREFORE, in consideration of the premises and of the sum of One Dollar paid by the Foundation to Brotherhood Corporation, the receipt and sufficiency of which is hereby acknowledged by Brotherhood Corporation, Brotherhood Corporation does hereby sell, assign, transfer, and quitclaim unto the Foundation the entire right, title, and interest, which Brotherhood Corporation has, or may have, in Australia in and to each and both of the Marks, together with the goodwill symbolized by the Marks and/or by each of them, as well as all rights and interests, both legal and equitable, in and to, and appurtenant to, the Marks, including (but not limited to) all rights of action for the present or past infringement of, or unfair competition with, each and both of said Marks in Australia.
