#### HISTORY OF THE URANTIA MOVEMENT

Several members of the group who participated in the preliminary contacts which led up to the appearance of the Urantia papers had had considerable experience in the investigation of psychic pehnomena. This group early arrived at the conclusion that the phenomenon connected with the personality suffect who was later associated with the Urantia papers, was in no way similar to any other well-known type of psychic performance—such as hypnotism, automatic writing, clairvoyance, trances, spirit mediumship, telepathy, or double personality.

It should be made clear that the antecedents of the Urantia papers were in no way associated with so-called spiritualism—with its seances and supposed communication with the spirits of departed human beings.

# CONTACT ACTIVITIES PRECEDING THE URANTIA PAPERS

As the Urantia Book indicates, the papers were received as follows: Superhuman personalities, the authors of the papers, sometimes called "the revelators," worked through the mind of a bleeping human subject, sometimes called "the contact personality." Also involved was a small group of human associates, called the "contact commission," who were charged with the responsibility of safeguarding the papers, putting them in typewritten form, handling all details of publication, securing copyrights, etc.

For a number of years before the presentation of thepapers, the contact personality and the contact commissioners went through what seemed to be a period of testing and training in the matter of technique of communication, etc., in a general way setting the stage for the subsequent presentation of the Urantia papera.

observations and investigations utterly failed to reveal the technique of reducing messages to writing, but it was established that it was not automatic writing. All the Urantia papers appeared in written form. Usually the verbal contacts were concerned with instructions and with miscellaneous information about the universe and affairs on our planet.

After some years of preliminary contacts, during which many new concepts of the universe and of Deity were implanted, it was found to suggested that questions of a sore serious nature should be asked in this was done order to elimit answers of supreme value to the human race. The result was that the Urantia papers began to appear.

At one time Dr. Sadler held a discussion with a small group of ministers who were studying the book, on "How We Did Not Get the Urantia Book." The following is a gist of that presentation:

## FUNCTIONING OF THE CONTACT COMMISSIONERS

Buring the early years the contact commissioners received many instructions and directives verbally and in writing. They were instructed to destroy by fire most of the written messages upon the appearance of the Urantia papers in print, apparently to prevent the appearance of an "Apocrypha," subsequent to the publication of the Urantia Book.

The commissioners were the custodians of the Urantia manuscript, and keeping the carbon copy of the typewritten transcript in a fireproof vault. They were also charged with full responsibility for supervising all the details connected with the publication of the book, securing the international copyrights, etc.

They were enjoined to refrain from discussing the identity of the contact personality and, after the publication of the book, to make no statement at any time as to whether the subject was still living or was deceased.



Among the several reasons given wax akakkucking for not discussing details of personal experiences associated with the origin of the Urantia Book, the two major reasons were the following:

1. Unknown Features. There is much connected with the appearance of the Urantia papers which no human being fully understands. No one really knows just how this phenomenon was executed. There are numberous missing links in the story of how this revelation came to appear in written English.

If anyone should tell <u>all</u> he really knows about the technique and methods employed throughout the years of getting this revelation, such a narration would satisfy no one—there are too many missing links.

2. The main reason for not revealing the identity of the contact personality is that the revelators do not want any human being—any human name—ever to be associated with the Urantia Book. They want this revelation to stand on its own declarations and teachings.

They are determined that future generations shall have the book wholly free from all mortal connections—they do not wantx a St. Peter, St. Paul, Luther, Calvin, ar Wesley.

The book does not even bear the imprint of the printer who brought the book into being.

Remember — you/xxxxx appreciate a good poem—even if you do not know the author. Likewise, you can enjoy a symphony even if you are ignorant of the composer.

Upon the receipt of these instructions, the contact commissioners entered upon the task of publishing the Urantia Book and preparation of planning of plans for its distribution.

The papers were published just as they were received. The contact commissioners had no editorial authority. Their job was -limited to "spelling, capitalization, and punctuation."

Before the death of DD. Lena Sadler in August 1939, she had collected about \$20,000 for the publication fund, and this handsman was used to set type and make plates for the printing of the book.

#### THE FORUM SHAPER

Many years ago Or. William S. Sadler made the suggestion to his son mutakin and to his wife that they try to maintain contact with former patients and friends by having an informal gathering Sunday afternoons to discuss matters of health, mental hygiene, and so on, and enjoy a cup of tea together. This group came to consist of professional men and women-doctors, lawyers, dentists, ministers, teachers-together with individuals from all walks of life-farmers, housewives, secretaries, miximum and common laborers.

During a discussion on psychic panomena, the doctor said that with one or two exceptions all the psychic pehnomena which he had investigated had turned out to be either conscious or unconscious frauds. Some were deliberate frauds-others were those peculiar cases in which the performer was a victim of the deceptions of his own subcanneious mind. Someone in the group asked about the one or two exceptions and the result was that some notes were produced which had been made during a recent contact. At that time there was no secrecy connected with the case. This was during the preliminary period before the Urantia papers began to appear.

The group/started to ask questions in writing concerning Deity,

ion, evolution, and so on, and as a result of these questions. creation, evolution, and so on, and as a result of these questions the Urantia papers started appearing.

At about this time instructions were received from the superhuman personalities to form a closed group. Membership tickets were issued and the charter membership number thirty. From time to time new members were received into the Forum, after being interviewed by the officers and after signing the same pledge that was signed by the original charter members. This pledge read: "We acknowledge

Cur pledge of secrecy, renewing our promise not to discuss the

Urantia mevelations or their subject matter with anyone save active

Forum members, and to take no notes of such matter as is read or discussed at the public sessions, or make copies or notes of what we personally read."

The last meeting of the Forum as a genetic assembly was held on May 31, 1942. During its existence the membership figure mounted to a total of 486. From this date in 1942 the Forum continued as a study group to the time of the organization of the First Urantia Society in 1956.

#### THE SEVENTY

In 1939, it appeared that the time had come to form a class to engage in the more serious and systematic study of the Urantia papers. This project was presented to the Forum and when those who wished to join such a group were counted, it was found that just 70 persons desired to enter upon this study. So for several years this class was referred to as "The Seventy." Two or three years preceding the formation of the Seventy an informal study group had been meeting on Wednesday evenings.

The Seventy carried on systematic study of the Urantia papers from April 3, 1939, to the summer of 1956, and was the forerunner of the later "School of the Urantia Brotherhood."

During these years the Seventy enrolled 107 students.

While an appeal was made for \$50,000 to defray the expense of printing 10,000 copies, Theores course was made only to the members of the Forum group and the response was immediate. The sum contributed was in excess of \$49,000.

With the Urantia Foundation acting as publisher, the Urantia Book was published under international copyright October 12, 1955.

### THE URANTIA BROTHERHOOD

It was inevitable that some sort of fraternal organization would grow out of the teachings of the Urantia Book. All interested persons could see that the Urantia teachings were opposed to the sectarianism of Christian believers. At was clear that it was not the purpose of the Urantia revelation to start a new church.

A constitution and by-laws were adopted, and since that date several presents local societies have been formed throughout the United States.

When ten or more persons who are familiar with, and believe in, the teachings of the Urantia Book so desire, they may be chartered as a Urantia Society. Membership in any church or fraternal organization does not interfere with becoming a member of a Urantia Society.

The Carrier of the Brotherhood and their successors were to direct the organization for the first nine years. Thereafter, the Brotherhood would be directed by the action of a Triennial Delegate Assembly composed of delegates from the various Urantia Societies.

The chairmen of the committees, together with the Brotherhood officers, constitute the Executive Committee of the Brotherhood.

The purpose of the Brotherhood is well expressed in the preamble to the constitution, as follows:

"Inasmuch as it is our most solemn conviction that the comfort, happiness, and well-being of man will be anhanced by the creation of an organization devoted to the purposes and inastruction of a constituted indicated that hereinafter expressed may best be accomplished through the purposes through the mutual assistance and association of a body of people working together for a common cause, we do hereby unite together as a voluntary association and fellowship under the name of Urantia Brotherhood, and we do hereby adopt and establish this constitution of Urantia Brotherhood."

The original 36 founders became the General Council which was designed to govern the Brotherhood for its first nime years.

Since the Urantia Brotherhood is not a corporation—a legal Od. 21, 1955
