AFFIDAVIT OF BUD KAGAN (aka M. H. KAGAN)

Bud Kagan, upon his oath, deposes and states

1 I am presently a resident of British Columbia, Canada. I was born in Chicago, Illinois seventy years ago and because of propitious circumstances I was able to meet with William S. Sadler, Jr. (hereinafter called Bill) in 1949, and his father Dr. William S. Sadler, M.D. in the early 1950's. I subsequently was a resident of the States of Arizona, California, New York, Hawaii and countries of Egypt, Italy, France, Japan and Iran.

2 I spent some years in the U. S. Army Air Forces, which became the U. S. Air Force and subsequently after an honorable release from military service my principal occupation was as an airline pilot for a major international Flag Carrier. In the course of these activities I frequently had stopovers and even layovers in Chicago where I met with both Sadlers described in paragraph 1.

3 Bill Sadler became a very close friend and our relations were most cordial. I had knowledge of the activities going on at the building in Lincoln Park district of Chicago (known as 533 Diversey Parkway) then the home and office of Dr. William S. Sadler, M.D. and his family. I also was a frequent visitor to the office of Bill Sadler at 333 N. Michigan Avenue in Chicago and his Lakeshore Drive Apartment in Chicago.

4 On many occasions I was a guest of Bill Sadler at his home, and he at my home for periods that went on for as long as two weeks. During these visits the main topic of our discussion was the Urantia Papers and the origin thereof. As an airline pilot I sought out trips to Chicago to meet with either Bill or Dr. Sadler and his close associates at their office/residences. Dr. Sadler (father of Bill) would also discuss with me the origin of the Urantia Papers and many other fascinating stories about them.

5 Dr. Sadler and Bill Sadler each, on several occasions stated to me the following narrative, the facts and truth of which I know to be valid.

(a) Each were members of a group known as the "Contact Commission" a group of six persons engaged in the activity of receiving the Urantia Revelation in the English Language. Subsequent to the untimely death of Lena K. Sadler (the spouse of Dr. William S. Sadler) only five individuals remained as contact commissioners.

- (b) Each of the contact commissioners collectively or as individuals received drafts of the Urantia Papers, although they stated that they did not understand the method and manner in which said Papers were transmitted
- (c) The Urantia Papers were authored by a group of nineteen different orders of super-human personalities, approximately ninety individuals in number, none of which were mortal or human beings
- (d) These super-human personalities were various orders of Divine beings headquartered at the center of the Universe of Universes, or domiciled in the Superuniverse headquarters worlds or the Local Universe and Constellation or System headquarters, some were temporarily resident on this planet from time to time
- (e) Part IV of the Urantia Papers (Papers 120 - 196) originated as follows:

However, the Forum kept going over these papers and asking questions so the Revelators could clarify their expressions to be more understandable to the mortal mind. The Forum went through all the papers at least three times. To estimate the time involved consider 118 papers completely gone through three times, one paper a week, 42 weeks a year (allowing for no meetings during the peak summer heat).

Paper 119 came through in 1935 just before the entire Part IV was delivered complete--typewritten, justified, punctuated and capitalized.

**Part IV -- the "Jesus Papers" -- delivered.**

All of Part IV was discovered in a vacant office, typewritten, next to the typewriter on which they had been produced. According to Bill Sadler this was not in the original Revelatory mandate, but the Urantia Midwayers enjoined the Commission and appealed all the way up the chain of command to include this narrative of Michael's final bestowal. It took one year (of our time) and the Ancients of Days ruled that it was not inconsistent with the Urantia Revelation to include the triumphant bestowal of Michael of Nebadon. A Melchizedek editor was appointed to work with the midwayer commission.



It is possible that the "Life & Teachings" were already composed by the Urantia Midwayers and submitted as part of their brief. See last sentence of 77:9.9.


The above is a published document on the world wide web, and I believe it to be true and accurate as it was related to me by Dr.Sadler, his son Bill and other early members of the Forum.
