I, WILLIAM S. SADLER, of the City of Chicago, County of Cook, and State of Illinois, being of sound and disposing mind and memory, do hereby make, publish and declare this instrument as my Last Will and Testament, hereby revoking all former wills and codicils at any time made by me.

ARTICLE I

1. I give and bequeath all tangible personal property which I may own at the time of my death, including, but not by way of limitation, jewelry, household furniture and furnishings, automobiles, books, pictures, silver, wearing apparel and all other articles of household or personal use or ornament (and all policies of insurance on such property), excepting therefrom, however, any tangible personal property of mine disposed of by paragraph 2, to EMMA L. CHRISTENSEN, of Chicago, Illinois, if she survives me, or, if said Emma L. Christensen does not survive me, to my grandchildren, PATRICIA H. MUNDELIUS and CHARLES GILL SADLER, in equal shares, if they survive me, or, if only one of said Patricia H. Mundelius and said Charles Gill Sadler survives me, to the survivor of them. I express the hope that said Emma L. Christensen or said Patricia H. Mundelius and said Charles Gill Sadler (or the survivor of said Patricia H. Mundelius and said Charles Gill Sadler) will dispose of said tangible personal property according to my wishes, however, my wishes may be made known to them, but I expressly declare that I do not intend to create any trust in law or in equity with respect to said tangible personal property.

2. I give, devise and bequeath the real property owned by me at 533 Diversey Parkway, Chicago, Illinois, together with the furniture and furnishings on the first floor thereof, to the URANTIA FOUNDATION, of Chicago, Illinois.

ARTICLE II

All the rest, residue and remainder of my property, real, personal and mixed, of every kind and nature and wheresoever situated, which I may own at the time of my death, including any lapsed legacies, devises and bequests, but not including any property over which I may then have any power of appointment, it being my intention not to exercise any such power (all of which is herein referred to as my "residuary estate"), I give, devise and bequeath as follows:

- I direct that my funeral expenses, my debts and the costs of administration of my estate be paid out of my residuary estate as soon as practicable after my death.
- 2. I direct my Executors to pay out of my residuary estate all Federal and state inheritance, estate, succession, transfer, income, gift and like taxes, including any interest or penalties thereon, arising or owing on my death (including the right to compromise and to pay as soon as practicable after my death any of such taxes on future or contingent interests), whether imposed on or with respect to property disposed of by this Will or on or with respect to property disposed of by this Will, except taxes with respect to property over which I may then have any power of appointment which was granted me by someone other than myself, without requiring

reimbursement for the payment of any such taxes from any person receiving property as a result of my death.

3. The balance of my residuary estate (said "balance" meaning my residuary estate minus the payments called for by paragraphs 1 and 2 of this ARTICLE II), I give, devise and bequeath, in equal shares, to such of the following persons as survive me:

My sister, MARY SADLER;
Said Patricia H. Mundelius;
Said Charles Gill Sadler; and
Said Emma L. Christensen

ARTICLE III

In extension and not in limitation of the powers given by law or other provisions of this Will, my Executors shall have the following powers and authority with respect to the settlement of my estate, in each case to be exercised from time to time in the sole discretion of my Executors and without order or confirmation of court:

- To retain indefinitely all or any part of the securities or other property included in my estate, notwithstanding any statute or rule of law regarding the diversification, character or suitability of investments by executors.
- 2. To sell real or personal property at public or private sale, for cash or credit, with or without security, and without notice, and to exchange, lease, give options for, and make contracts concerning the same, upon such terms as my Executors in their sole discretion may determine; and to execute deeds, transfers, leases and other instruments of any kind.

- To employ investment counsel, custodians of estate property, brokers, agents and attorneys.
- 4. To settle, compromise, contest, or abandon claims or demands in favor of or against my estate.
- To make any division or distribution of estate property in cash or in kind or partly in cash and partly in kind.

ARTICLE IV

- 1. I nominate and appoint ALVIN L. KULIEKE, of Prospect Heights, Illinois, and said Emma L. Christensen, or the survivor of them, as Executors or Executor of this my Last Will and Testament; and in the event that both said Alvin L. Kulieke and said Emma L. Christensen die, decline to serve, cease to serve or fail to qualify in such capacity, I then nominate and appoint THE NORTHERN TRUST COMPANY, an Illinois corporation, of Chicago, Illinois, as Executor of this my Last Will and Testament.
- 2. No bond shall be required of my original Executors or Executor or of any successor Executor hereunder, or, if a bond is required by law, no surety on such bond shall be required.
