Dear Vern:

We do appreciate very much your telling us in your letter of April 7 that you have mailed two more books to India. We are glad to see that your work in India is bearing fruit in this way.

Vern, we would like to ask you a favor having to do with sending URANTIA Books to India and other foreign countries. Confidentially, the URANTIA Foundation has never made proper trademark or service mark usage in India, although there are 7-10 URANTIA Books there now. At the present time, the Foundation is obtaining trademark and service mark registrations for the word URANTIA and the Concentric-Circle Symbol in India, and it is important that we make use of these marks in the near future. Therefore, we wondered if the Family of God Foundation should have occasion to send additional books to India if you would let the URANTIA Brotherhood Corporation as Agent of URANTIA Foundation do the mailing for you, at least for a few copies, in order to show continued usage there of these marks. The URANTIA Brotherhood Corporation would, of course, frame a letter to your liking stating that the book (or books) is a gift of your organization.

Since you order your URANTIA Books in quantities of 10 and, therefore, obtain them for \$12.00 a copy, we would give you individual books for the same amount for this purpose. We would pay the postage as we would want to send these books by Registered Mail. Please let us have your reaction to this suggestion.

Perhaps you will be sending URANTIA Books to other foreign countries from time to time where the Foundation has not yet established its marks. We are enclosing a Confidential List of all countries where the Foundation has made proper trademark usage. If you have occasion to send books to countries not on this list, perhaps you would permit us to make the same arrangement as requested above with respect to India.
