

Dear Friends of UAI,

It will be an opportunity to extend our friendship while expanding our awareness of the growing brotherhood. It will also be a time for rejoicing and gathering new strength and energy for the coming year. When we go to conferences, most of the time we all come back with a lot of enthusiasm and determination. But beware of the “conference blues,” it lies there a few weeks after our return home and unless we channel that new-found energy in worthwhile actions, we suffer withdrawal symptoms. Conferences generate emotional highs in some of us, and one way to use that effectively is to engage ourselves in creative activities as soon as possible after our return home.

In the years to come, when the strategic plan is well in place, conferences will be more focused on our mission and should provide ample opportunities to channel new emerging energies in worthwhile projects and workshops coherent with our mission. It should provide the organizers with new challenges and many opportunities to increase their skills in leadership while providing the attendees with workshops and activities focused on dissemination, education and personal growth. It will also leave plenty of room for creativity, autonomy and improvement.

During the last weekend of July, the team for the strategic plan will have met for the third time in Chicago. After the final revision, which should be in the weeks to come, the strategic plan will be sent to the Representative Council for approval. This plan is designed for the International Service Board and needs the cooperation of all of us to succeed. Every association is strongly encouraged to build their own plan and the ISB will provide them with a model.



To enlighten some of you who are not familiar with a strategic plan – here is a good explanation of its structure and use. Whether we realize it or not, everyone to one degree

or another operates with a tactical plan. Very few of us have a strategic plan. What is the difference? A tactical plan is very short term. It is a statement or thought of what you plan to do in the next few hours, days or months to achieve something. A strategic plan is a statement of what one plans to do in the next five years or more; a road map that details the steps to take to achieve one or more goals. The ISB has been working for some months to formulate a five-year strategic plan for each committee and officer in the ISB.

Such a plan is necessary for several reasons. First, it sets definitive goals for each committee and officer. Second, it provides a structured sequence of activities that will be taken to achieve those goals. Third, it sets a reasonable time frame to complete each task. Strategic plans are not static. They must be dynamic because the world is ever changing. Humans are not able to anticipate every change that will affect their desired outcome. Thus, fourth, the plan is a codified path that allows each committee chair and officer to know what they must deviate from as circumstances change. The ISB will review its strategic plan at least yearly to access and adjust it as necessary.

Here is what is happening at the ISB - we are still struggling to get every new member comfortable with their new-found responsibilities, there is still some progress to be made. Meeting without the benefits of a face-to-face interaction has its own drawback and the ISB is always adjusting to this reality. The ISB members are looking to find a replacement for a member of the Judicial Commission, once a person is found, an election will be held at the RC to elect new members to this commission. If you know of any one that could be interested in such a position, please let us know. We are also looking to finish the strategic plan and have also started discussions on the possible


EUROPE WAS IN DISARRAY AT THE CLOSE of the World War II in 1946 and my parents found themselves stateless as their homeland Latvia, was absorbed into the Soviet Union. They chose Australia, a land far from conflict to start a new life. ## How *THE URANTIA BOOK* found me

**M**Y NAME IS TAMILA RAGIMOVA, I WAS born in the ex-Soviet Union, in the city of Baku, capital of Azerbaijan. Baku is in the peninsula of the Caspian Sea separated of Russia by mountains of the Caucasus. Now Azerbaijan is an independent country and has borders with Iran, Armenia and Georgia.

Azerbaijan historically is an Islamic country, but in the Soviet Union after the revolution of year 1917 they prohibited all class of religions, therefore I did not have any religious education. In my family we only celebrated the Islamic and also Christian celebrations, because my father was Azerbaijani and my mother was Russian.

The Islamic customs in Azerbaijan, were not as strong as in Iran, but the freedom of the women was very restricted, many things and customs of city of Baku did not please me; for that reason I had very deep desire to leave Baku and to live in another city, but it was not easy to make this, being a girl in a Muslim country.

On the part of my father we are descending of the kings of Iran, of the Qajar dynasty of Persia, but I did not know this until I was 30 years old.

In my family we are three sisters and I am the oldest one. My mother became ill of the nervous system in the age of 42; the disease lasted 5 years, slowly taking her to her death. At this time I finished the school, with an award for academic achievements and entered the university to study Physics.

Since the early years of my life I was more of a spiritual person rather than materialist, and with certain talent in humanities, such as literature, poetry, art, geography, history, but all at once I "decided" to study physics which is a very complex science. When I was 18 years old, also was interested to know the secret of the formation of the universe, I wanted to find out who we are and what the reason of our existence is.

I read many scientific books on these subjects, thought that the physics of relativity

could respond to these questions. Now I understand, that my decision to study physics, was guided by my adjuster and other celestial beings, who took me to this way of study for my progress and integral development, because studying physics and mathematics develops the mind and the logic of thinking.

From very early years I was very sensible and always there was a thought in my head: "I must develop my power of will and the inner strength." I trained my will permanently, thinking: "I can not be enslaved by my desires; I must handle my attitudes with the mind." It is as if I had a feeling that soon I would learn, that "the self-control is the measurement of the moral nature of the man and the indicator of its spiritual development." 1609

Now I understand that my guardians took care of me a lot and they guided me to the way of integral development of human personality. In youth I had a very rigorous discipline; I practiced rhythmical gymnastics like professional sportswoman, studied physics in the university, took care of my ill mother and educated my younger sisters.

In 1970s I finished my studies in physics with the specialization in semiconductors and finally I could find a reason to leave Baku. At this time "appeared" a possibility of studying a doctorate in the Academy of Sciences in Moscow.

The experience of the life in Moscow was extraordinary, because during 10 years of studies, I lived in a residence of doctorate students, where people lived from all parts of the world; I learned the customs and the cultures of the people from Europe, Africa, Asia, America and almost all the nationalities of the Soviet Union.

I understood that all the human beings are equal, that many good people exist and this quality does not depend on the country of birth. Also I learned that everywhere, there are

many primary people, who are only concerned about material things, the power and to feel superior to the others. Although these people have intelligence to hide these defects, one can feel this egoism with frequency.

After making Ph. D. in physics and mathematics of semiconductors, I tried to remain and live in Moscow, but I could not because I did not have my own house in Moscow, this was the situation of that time, but in any condition I did not want to return and live in Baku, really there was no solution.

Once again the solution arrived from the sky, "appeared" my marriage with a Colombian who lived in the same residence in Moscow and I had to come to live in Colombia, in the city of Medellín.

The marriage lasted a very short time, because there was a total mutual incompatibility, but I liked a lot the life in Colombia, the people, the treatment of one to another, the climate and everything.

Quickly I found an educational job as physics teacher in University of Antioquia, and began to dictate lections even though spoke very little Spanish.

In the university I founded a laboratory in physics of semiconductors and began to work hard in the investigations the growth of semiconductors and their physical properties. I used to travel frequently to the national and international congresses, had joint works with different universities of Colombia, America and Europe.

Up to 1996 I was a normal person, that is to say, "a normal" physicist, who knew all the concepts of energies that the physics handles, the other terms like Bio Energy and Spiritualism made me laugh because the physics does not handle this class of concepts, that is to say, thought like all "the normal" physicists; those energies the physics does not know do not

exist, neither exist “parallel worlds”, “celestial beings”, etc.

Then, in 1996 the divine providence touched me again and in a very particular form, that changed all my life. “Appeared” very strong headaches and I felt a deep cold within my head, had to dictate lections with a knitted cap, when the temperature in Medellin was 30°C.

All medical examinations, the TAC, magnetic Resonance and others, demonstrated that I did not have any disease, but the pains continued.

The general medicine could not heal me, so I began to look for another way of treatment, therefore visited several Bio Energetic doctors and people who cured with other methods, the disease lasted a year.

At this time I discovered a surprising spiritual world that I did not know before, I began to read books of Elena Blavatskaya, the Bible, the Koran, Alan Kardec, Mayas and many others, I practiced regressions, but none of these new knowledge could satisfy my desire to know the true cosmic reality.

One day “appeared” *The Urantia Book*, lent to me and I began to study it strongly, discovered a world totally different from everything what physics had taught me and of everything I learned in this last year of my headaches.

The Book had a big impact on me by the information that contained and the scientific form of explanation of the appearance and administration of the Universe of the Universes. Like many people, the first part seemed to me very complicated but now it is not like this any more and it is natural since “The revelation must always be limited by the man’s capacity of receptivity” 1007.

I think that during a year which I had headaches, they were preparing me for a crucial discovery in my life that is *The Urantia Book*.

The information and the lessons that this book contains is the greatest progress the human being has had in the human knowledge, much greater than all the scientific and technological progress that had the planet earth in twentieth century.

## UAI registered in State of Illinois as not-for-profit

**T**HE LONG AWAITED UAI OPERATING autonomy is now at hand. UAI released from Urantia Brotherhood Association, Inc, allowed us to form a new corporation. UAI is registered in the USA, State of Illinois, as not-for-profit. After many discussions about our name, we have now submitted application to United States Internal Revenue Service (IRS) for recognition of tax exemption. Preparation involved answering many questions and writing responses. An application package was submitted on May 8, 2007. IRS staff is busy and therefore we may not receive a final ruling for many months.

Tax exemption status is beneficial for USA citizens and others who file a USA tax return and who wish to deduct charitable donations from personal and/or corporate tax filings. Other UAI national associations are encouraged to research their laws and rules for possible benefit within their nations. Although UAI release occurred in 2005, the delay was due to many name change discussions and the complex paperwork.

Chicago attorney Quin Frazer assisted us in preparing the Illinois corporation registra-

tion and the tax application. The process involved researching Illinois and USA Federal laws and instructions, ISB members writing a narrative of activities for each committee, a long application form that includes a certification of no ethical conflicts with ISB members, staff, and vendors, and submitting all financial data. Shirley Pelland, James Woodward, Mark Kurtz, Judy Van Cleave, and Merindi Swadling reviewed the application.

IRS acknowledged receipt of our application. Deductible donations are allowed during their review period. It is expected IRS will issue a favorable determination and this would mean permanent exemption status. This status is attractive to donors and greatly enhances income potential for UAI.
