Dear Dr. Calabrese:

Thank you very much for your letter of July 8. We sincerely appreciate your comments in further clarification of your qualifications for presentation of your proposed course. You will note by copy enclosed our reply to Dr. Hunt.

The concept of a Urantia University is one that all here fondly keep in the reserve areas of our minds. So far with us it represents an attainment of evolutionary growth and experience rather than an objective to be directly pursued. When an objective is pursued directly the attainment thereof as such is paramount and the temptation to utilize short-cuts and improvisations is ever present. Should this occur the finished product may suffer from insufficiency at times and might conceivably turn out to be a facade rather than an enduring structure. If one considers the fact that our Creator could have produced perfect men and women fully endowed for their assigned tasks had he so desired, it is obvious that the emphasis which he places on growth and experience is something for us ever to bear in mind.

Your reflections on the Urantia Papers are most pertinent and as one who majored in Chemistry with minors in Biology and Physics the comments in paragraph 4, page 2 of your letter are most interesting. The materialists you refer to often give me the impression that they are so locked into their area of concentration, so concerned with the literal correctness of the material facts involved that they lose sight, temporarily, that interpretation of these facts integrated into our life system involves the application of philosophy and eventually an attempted evaluation of values. I sometimes refer to this as compartmentalized thinking.

Again thank you for your comments. We feel, as a result of our perusal of them, that we know you better and are opening mutually effective avenues of communication. We shall look forward to additional communication in the future.
