Dear Martin:

URANTIA Society of Greater New York has considered URANTIA Foundation's letter of August 1, 1990. This letter contains a number of statements with which we do not agree:

- 1. URANTIA Society of Greater New York has been and chooses now to remain affiliated with URANTIA Brotherhood, now known as Fifth Epochal Fellowship. This affiliation is, in fact, required under Article 8 of the Licensing Agreement between URANTIA Foundation and our Society. Were we to terminate our relationship with Fifth Epochal Fellowship (URANTIA Brotherhood), we would be in breach of said Licensing Agreement. We regard URANTIA Foundation's demand that we terminate our association with Fifth Epochal Fellowship (URANTIA Brotherhood) to be a breach of the Licensing Agreement.
- 2. The Licensing Agreement does not provide URANTIA Foundation with the authority to require our Society to affiliate with any organization other than Fifth Epochal Fellowship (URANTIA Brotherhood). Such a demand exceeds URANTIA Foundation's contractual rights and constitutes a breach.
- 3. The Licensing Agreement does not provide URANTIA Foundation with the authority to prohibit our Society from maintaining or establishing relationships with additional groups of our own choosing. Such a demand exceeds URANTIA Foundation's contractual rights and constitutes a breach.

Pursuant to Article 8 of the Licensing Agreement, URANTIA Society of Greater New York, as of September 9, 1990, formally charges URANTIA Foundation with default of the Licensing Agreement as stated above. We request that URANTIA Foundation correct the breaches within thirty days of September 12, 1990. Failure to do so will result in termination of the Licensing Agreement.

Specifically, we request that URANTIA Foundation:

- Retract its demand requiring URANTIA Society of Greater New York to sever its relationship with Fifth Epochal Fellowship (URANTIA Brotherhood).
- 2. Retract its demand requiring URANTIA Society of Greater New York to affiliate with any organization other than Fifth Epochal Fellowship (URANTIA Brotherhood).
- 3. Retract its demand requiring URANTIA Society of Greater New York to refrain from associating with any organization with which it chooses to associate.
